The findings of the Proposal Evaluation Committee are summarized as follows:

The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that the products and services offered in the proposal responses from CleanSpray USA, LLC, REJ California Group, Inc., and TerriCorp, Inc., fall outside of the Requested Equipment, Products, or Services of the RFP. All other proposals were found to meet the scope and mandatory submittal requirements and were evaluated.

Ford Motor Company, is a manufacturer of passenger cars and trucks, along with parts that has been in business for well over 120 years. They offer over 290,000 SKUs. Participating entities can be served by a dealer network of over 2900 dealerships as well as distributors across the United States. Pricing offered is competitive and includes strong discounts.

General Motors AC Delco, Inc. can provide a large inventory of GM and non-GM vehicle maintenance, repair, collision, and powertrain parts to Sourcewell's participating entities. Their 100-year history along with their 2500 dealers and 2100 distributor locations allow them to serve all areas of the United States. They offer a favorable discount on their list pricing.

Navistar Inc., has been building and selling buses and trucks for over 100 years. Navistar operates more than 600 dealer locations along with 7 distribution centers across the United States and Canada. Participating entity will have access to their Fleet Charge portal which gives them access to invoices and custom reporting capabilities. Attractive discounts are available to Sourcewell Participating Entities.

Paccar Parts (PACCAR, Inc.), Inc. has a history of over 100 years and can provide sales and service to Sourcewell's participating agencies.
