The findings of the Proposal Evaluation Committee are summarized as follows:

The Proposal Evaluation Committee applied the Sourcewell RFP evaluation criteria and determined that all proposal responses met the scope and mandatory submittal requirements and were evaluated.

Ameresco, Inc. is National Association of Energy Service Companies (NAESCO) accredited and has 60 offices throughout North America and Europe. With over 1,500 employees they manage and conduct audits, project development, procurement, project/construction management, and measurement and verification using in-house resources. Since their founding in 2000, Ameresco has developed and delivered over \$14 billion in comprehensive energy services and have helped customers secure more than \$3.5 billion in project financing through various sources.

CMTA is NAESCO accredited and has received numerous American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRAE) Technology awards. They have 44 offices in 16 states and 1,040 employees. With hundreds of past project experience, they offer a wide range of solutions available to all 50 states. CMTA offers detailed training ranging from equipment to safety and sustainability. High-performance design is engrained in their company culture.

Energy Systems Group LLC (ESG) is a vendor-neutral service company that is backed by Oaktree Capital Management L.P. ESG partners with 65 utility territories across the U.S. ESG is licensed and ready to work in the U.S. ESG's 380 employees prides themselves in helping customers solve their energy efficiency, resiliency, and sustainability challenges.
